

## **\*\*GENERAL TERMS AND CONDITIONS OF GSPRO\*\***

### **\*\*1. Subject Matter and Scope:\*\***

GSPRO, as mentioned at [gspro.network](https://gspro.network) (domain/platform), is a trade name of GS Digital Partners LLC incorporated in the Republic of Georgia with Business Identification Number 405472180. The company is registered with the Ministry of Justice of Georgia / LEPL National Agency of Public Registry. It is entitled to provide various services to customers outside the Republic of Georgia according to the Free Zone Financial License and Annex issued by the Hualing Free Industrial Zone with License Number: 0110/473. These services include Financial Services and Consulting, Cryptocurrency and Blockchain-related activities, e-wallet and Payment Processing Services, Professional Trustee Services to store and safeguard third party funds, Electronic Money Issuing, and Automated Signal Trading (including high frequency trading in FX and cryptocurrencies in real time) engaging with cryptocurrency services, included but not limited to operating cryptocurrency exchanges, cryptocurrency trading and operating of cryptocurrency wallet and storage services for digital assets. GSPRO operates as a fully compliant institution following European Standards (Sweden) to prevent Money Laundering and Terrorism Financing. GSPRO provides a wide range of IT and Telecommunication services to Non-GEORGIAN citizens and/or residents.

(3) GSPRO offers the above chargeable services, subject to separate agreements. Members may also register as distribution partners without immediate distribution obligations.

(4) Members will receive detailed information on chargeable orders, prices, and payment terms before committing. The contractual relationship is confirmed via email upon order confirmation by GSPRO.

### **\*\*2. Registration and Account Handling:\*\***

(1) Free registration on the GSPRO website is a prerequisite for using its services. Complete and truthful disclosure of required data is mandatory.

(2) During registration, members must select an email address and password. Pressing "register free of charge" signifies agreement to the General Terms of Use. The contractual relationship is established upon email confirmation, providing access to the website.

(3) GSPRO reserves the right to request age and identity verification as part of the Know Your Customer (KYC) process.

(4) Members are solely responsible for the legality and accuracy of the provided registration data.

### **\*\*3. Member's Obligations:\*\***

Members agree not to infringe upon third-party rights, harass, violate laws, or engage in inappropriate conduct while using GSPRO's services.

(2) GSPRO reserves the right to take legal action against individuals or entities found engaged in any unauthorized use, copying, editing, misrepresentation, broadcasting, or sharing of our content on social media platforms. This includes, but is not limited to, text, images, videos, and any other form of intellectual property owned by GSPRO.

**\*\*5. Server Availability:\*\***

GSPRO services operate 24/7 with an annual average availability of 90%. Downtimes due to maintenance or technical issues are excluded.

**\*\*6. Limitation of Liability:\*\***

(1) GSPRO is not liable for member-provided information's accuracy. No guarantees are made regarding member success or desired outcomes.

(2) GSPRO is not liable for damages resulting from software use. Liability is limited to willful or grossly negligent conduct.

(3) GSPRO is not liable for damages arising from data losses on servers, excluding grossly negligent or intentional misconduct by GSPRO.

**\*\*7. Data Protection:\*\***

(1) GSPRO collects and uses data voluntarily transmitted by members within statutory provisions. Detailed data protection provisions are available in the Privacy Policy.

**\*\*8. Miscellaneous:\*\***

(A) GSPRO holds all rights to trademarks, copyrights, and contents on its platform.

(B) Registration and profile creation are free. Prices and fees are processed through online payment service providers.

(C) GSPRO may modify its services without notice.

(D) Members agree to the immediate execution of contracts upon registration.

**\*\*9. Changes; Applicable Law; Severability:\*\***

(1) GSPRO may change this contract with a notice period of six weeks, communicated via email.

(2) Disputes are subject to the laws of GSPRO's registered office. GSPRO does not participate in dispute resolution proceedings.

(3) Invalid provisions do not affect the overall validity of the Terms and Conditions.
